# **Terms & Conditions for Workshops**

## 1. Acceptance of terms and conditions

By completing the registration form for th, you are agreeing to the terms and conditions set out below ("**Terms**"). They will come into effect when we send you a booking confirmation.

## 2. Terms of payment

All bookings made within 30 days prior to the experience, a full payment must be made at the time of the booking. For all bookings made 31 days or more prior to arrival to the experience, a 25% non-refundable deposit must be paid at the time of the booking. The remainder of the total price is to be paid 4 weeks (28 days) prior to the experience. If payment in not received 28 days prior to arrival, we will treat this as a cancellation of the booking and withdraw its confirmation of services.

## 3. Refunds

All spots sold in this experience are non-refundable. In some force majeure cases, we might accept to offer a (partial) refund depending on the time of the cancellation. Please refer to the paragraph below. A cancellation request must be sent to Julie Stamenic in writing, by e-mail, and needs to be confirmed by herself order to be valid. In conformity with our business practices, the participant is required to pay cancellation fees on the total price as follows:

#### Time of cancellation:

More than 2 months before the experience: 25% 2 months and more than 3 weeks (21 days): 50% 3 weeks (20 days) and more than 72 hours: 70% 72 hours' notice and less: 100%

# 4. Cancellation

Though very unlikely, there may be circumstances in which we need to cancel the Workshop. In such circumstances, we will provide you with a full refund of the amount of the Registration Fee that you have paid to us and we will make great efforts to provide you with such refund within 30 days of the date of cancellation.

# 5. Liability and Disclaimer – important, you must read this

Our sole liability in relation to any cancellation, postponement or change of venue shall be limited to the price paid by you for such Workshop and we shall not be liable under any circumstances for any consequential losses. We act in good faith and disclaim responsibility for any loss, damage, accidents, sickness or schedule changes caused by weather, force majeure such as natural catastrophes, strikes or any irregularities beyond their control. Julie Stamenic & Aquachara cannot be held responsible for loss or damage to camera equipment during the whole duration of the workshop. All medical costs arising during the workshop must be paid by the client. Loss of or damage to luggage is at the client's own risk.

## 6. Your obligations

If you act in any way which in our opinion is likely to cause any harm or nuisance to any person at the Workshop, you will be required to leave the Workshop and we shall not be liable to refund your Registration Fee or any other payment.

You must comply at all times with the health and safety policy of the venue. You must comply with all requests from us or the venue with regard to health and safety and failure to do so will result in you being asked to leave the workshop (in which case no refund will be provided). You may not bring any equipment or items of a hazardous or dangerous nature to the Workshop (e.g. FPV drones). You shall not cause any damage to any part of the venue (including outside areas, and all inside walls, flooring, fixtures and fittings).

You are solely liable for any damage caused to any such area of the venue and shall fully reimburse us in relation to any damage so caused. You must keep your personal belongings with you at all times and we accept no liability for any damage to, loss of or theft of any of your belongings or other items brought to the Workshop by you.

# 7. Photography and filming

We may wish to photograph or film some parts of the Workshop and reserve the right to do so for the purposes of promoting future workshops or otherwise. You consent to us (or any other person attending the Workshop) photographing or filming you and any persons attending the Workshop with you.

# 8. Data protection

We will communicate with you using the contact details provided on the Registration Form (and email confirmation) for the purposes of the Workshop (e.g. Whatsapp Group)

# 9. Travel, accommodation and refreshments

You shall be responsible for making and paying for your own travel and accommodation arrangements to and from the Workshop. If you are late at the workshop or prevented from attending the Workshop due to travel delays or any other circumstances, we shall not be obliged to provide you with a refund or to wait to start the Workshop until you arrive.

# 10. Disability, medical conditions and dietary requirements

If you have any disability or medical condition that requires us to make special arrangements for you or any special dietary requirements, please let us know in the form when registering.

# 11. Limitations of Liability

Whilst every reasonable precaution is taken by us to ensure security and safety at the workshop, we shall not in any way be liable for any loss or damage suffered by you whatsoever in relation to the Workshop, save that nothing in these Terms shall be deemed to limit the liability of any person for death or personal injury caused by negligence.

Nothing in these Terms shall limit or exclude our liability for death or personal injury caused by our negligence, any fraudulent misrepresentation or any other liability for which it is unlawful to exclude or limit liability. Our total liability for any matter happening during the workshop shall in all circumstances be limited to the price paid by you for the Workshop and we shall not in any circumstances be liable to you for any consequential loss whatsoever.

#### 12. Governing law

These Terms shall be governed by the French Law and your hereby submit to the exclusive jurisdiction of the French Courts.
